What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Nickel is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Nickel futures contracts. The ETC aims to replicate the Bloomberg Commodity Nickel Subindex 4W Total Return Index (BCOMNI4T) by tracking the Bloomberg Nickel Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Commodity Nickel Subindex 4W Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Commodity Nickel Subindex 4W Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

Intended Retail Investor

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Nickel between 04/12/2014 and 23/11/2015. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Nickel between 10/05/2016 and 27/04/2017. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Nickel between 18/03/2021 and 07/03/2022. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What are the costs?
